However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on your statement describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL

DIRECTOR & STAFF.....\$1925.00

Our basic service charge includes, conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing obituary notices; obtaining necessary authorizations and permits; and coordinating with the cemetery, crematory, and other third parties. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, and administration and equipment costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING..... \$500.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

The charge for direct cremation, without any attendant rites or ceremonies, includes removal of remains, sanitary care and preparation of remains, local transportation to crematory, necessary authorizations, crematory charge, medical examiner fee, and the basic services of funeral director and staff.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is a fiberboard container.
