Dear Member:

I am delighted to announce the bequeathal of \$5,000 from Sarah Gelfand Deutschmann, a former piano teacher and member of our Memorial Society. Her generous gift was bequeathed to MSNE out of gratitude for our help to her and so that MSNE could continue to help others.

As you may recall, one of our major accomplishments last year, was to obtain a Federal tax exempt status by the Internal Revenue Service under section 501(c)3 of the Internal Revenue Code. This means that since the MSNE has been recognized as a truly philanthropic organization, all donations and bequeathals are tax exempt.

Many of you, in your plans, have asked that donations be made to your favorite charities, such as the New England Eye Bank. That is, rather than have your family/friends send flowers to your services you have asked that they make donations to certain organizations. You may have also made arrangements in your will to give to charities. We urge you to consider MSNE, similarly.

All types of donations, whether large or small, are welcome. Again this year, we are asking for voluntary dues and contributions. The amount you give defers the cost of keeping your membership record in a computerized file and continuing to provide you with the full range of membership benefits.

In addition, MSNE pays small salaries to 3 dedicated staff who take care of the day-to-day office

operations, respond to inquiries and take emergency calls at home on a 7 day per week basis as well as implement our outreach programs. This year, these programs include:

- Speaking at Senior Home Care, Charlestown Library, Sacred Heart Church, Church of Our Savior, and Judge Baker Family Support Center;

- Media appearances on Channel 56 and Arlington Cable Television;

- The formation of the first "Church Satellite Membership."

In addition, plans were begun to produce a 30 second television spot which will be given to the major stations in Boston to be aired as a public service announcement.

After reading the financial report (also contained in this newsletter) you will see how dependent MSNE is on your annual giving. Although we are still operating at a deficit, we have been able to reduce the amount from what it was a year ago because of our 501(c)3 status and because we have cutback in salaries. Nevertheless, we are still operating in the red.

Please give as generously as you can.

FIRST CHURCH SATELLITE IS LAUNCHED

Last year, as one possible answer to the need to encourage more people to join MSNE and at the same time deliver on-going valuable information and services to members the MSNE Executive Committee suggested that MSNE work through churches/temples to form satellite memberships.

Last Spring, the First and Second Church sponsored an evening at which George Marshall, a member of MSNE and the church, and Doranne Jung, MSNE staff, spoke. The intent of the event was not only to make church members aware of the issues involved with funeral planning, but also to establish a satellite membership within the church.

As a result of this event, a handful of people volunteered to serve on a committee. They met several times after services on Sunday to discuss and agree upon their purpose:

-- to provide information on MSNE and on how to pre-plan to church members on a personal one-to-one basis.

That is, they felt that people who want to talk about their funeral plans might do so more readily with members of their own church rather than with MSNE staff over the telephone. To help the committee get started the church printed all the committee members' names in its bulletin; MSNE provided information and brochures.

Three authors will discuss their views on a variety of issues concerning death and its role in the life process:

EARL A. GROLLMAN, Rabbi, Beth El Temple Center, (Belmont, MA) since 1951, has been a pioneer in family crisis intervention and is internationally known for his work concerning dying and bereavement. He has appeared on numerous national radio and television shows. His publications have won him acclaim from both religious and professional counselors.

He is the author of many books including Talking About Death, which received the Trends Citation by UNESCO at the International Children's and Youth Book Exhibition, What Helped Me When My Loved One Died, Explaining Death to Children, Concerning Death: A Practical Guide for the Living, When Your Loved One Is Dying and many more.

He is a member of the Professional Advisory Board of the Foundation on Thanatology at Columbia-Presbyterian Medical Center, N.Y., and an editorial advisor to Omega magazine; he is also a member of the Bereavement Team of the Community School of Psychiatry at Harvard University.

AVERY WEISMAN, M.D., has long been recognized as a pioneer in Thanatology, the psycho-social study of death, dying and life-threatening behavior.

He is the author of numerous professional papers and books, the latest of which, Coping: On the Nature of Being Mortal is scheduled for publication in 1984.

Most of his career has been at the Massachusetts General Hospital, Boston, where he is now Senior Psychiatrist and Professor of Psychiatry at the Harvard Medical school. He is certified in neurology, psychiatry and psychoanalysis. For many years he was Principal Investigator of Project Omega, a group which has studied coping and vulnerability among cancer patients.

Honors he has received include Sutherland Award by Memorial Sloan Kettering Hospital and the Distinguished Human Services Award by Yeshiva University.

He is a member of MSNE.

GEORGE N. MARSHALL, Minister/Director, Church of the Larger Fellowship (Unitarian Universalist), Boston since 1960, has been minister of churches in Plymouth, Mass. and Niagara Falls, N.Y. He holds degrees from Tufts, Columbia, Harvard and Walden Universities.

He is the author of The Church Of The Pilgrim Fathers, An Understanding of Albert Schweitzer, The Quest for Serenity (a biography), Challenge of a Liberal Faith, and Facing Death and Grief, published in 1981.

Rev. Marshall has travelled widely and preached on five continents. He has been active in many denominational and community capacities. Besides a Ph.D. degree, he was awarded the honorary Doctor of Divinity degree by Meadville/Lombard Theological School.

He is a member of MSNE.

JOHN BUCKLEY will introduce the three authors and act as moderator during the question and answer period. His biography is included in this newsletter under "New Directors."
